Monthly Pay Cycle - Payday is the 1st of the month. If the 1st falls on a weekend or holiday, the pay date is the preceding business day, with the exception of January's payday (which always falls on the first business day in January).

CruzPay is UCSC's online time reporting system. Information about your CruzPay account will be sent to your @ucsc email if you are required to submit a timesheet.

- **Monthly employees** with appointments that are eligible for leave (vacation, sick leave, paid time off) are required to submit a time sheet every month; reporting leave taken, if any.
- **Biweekly employees** are required to submit a timesheet every biweekly pay period; reporting hours worked and leave taken (if eligible). To ensure on-time pay, please submit your timesheet by the deadline.

### EMPLOYEE ID CARD

Your Employee ID card officially identifies you as a UCSC employee. Some of the services where you can use your Employee ID card include: Transportation and Parking Services (TAPS), library services, and the fitness center.
